## **GENERAL INFORMATION**

RNA FRUIT WASH is specifically designed for the washing of agricultural crops pre- and post-harvest, which aids in the removal of honeydew (from such insects as whiteflies, aphids and psylla), dirt and wettable powder residue.

### **DIRECTIONS FOR USE**

For best results from in-field applications to growing crops, treatment should be made in the morning before the dew evaporates.

Use 3-16 fluid ounces per 100 gallons of water, depending upon severity of the problem. Under most conditions, rates of 6-8 fluid ounces per 100 gallons of water will be sufficient to wash most crops of dirt and honeydew. Use lower rates per 100 gallons of water for dilute sprays and higher rates per 100 gallons of water for concentrate sprays.

The addition of an organosilicone surfactant can improve the performance of RNA FRUIT WASH.

#### **USE PRECAUTIONS**

The pH of the RNA FRUIT WASH spray solution should be no lower than 4.5. This product contains sufficient defoamer to prevent foaming. Excess agitation of this product will cause foaming. If foaming is excessive, stop all agitation and allow the dispersed defoamer to rise to the top of the spray solution. After foam subsides, continue application or treatment with decreased agitation.

For crops highly susceptible to crop injury, such as table grapes or plums, always test this product in a small area at the same concentration and with the same materials to be applied at full scale. This precaution is especially important when RNA FRUIT WASH is used in concentrate sprays.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

**PRODUCT STORAGE:** Store in original container only and keep container tightly sealed. Store in closed storage area, **PRODUCT DISPOSAL:** Dispose of contents in accordance with all government regulations.
