To improve the vigor of trees and vines, apply 5-15 pounds per acre to the foliage with sufficient water for thorough coverage. Apply 3-4 times at 2-week intervals. Under normal circumstances, this product should improve vegetative growth or provide a flush of growth by freeing-up existing nutrients stored in the plants and roots. Best for use on stalled non-bearing trees and vines and ornamental crops.
