## GENERAL INFORMATION

RNA TIMBER™ is a 100% modified vegetable oil/surfactant blend that aids in the penetration of herbicides through a plant's waxy cuticle.

RNA TIMBER may be used in place of crop oil concentrates in spray mixtures. When used as directed, RNA TIMBER maximizes the activity of certain herbicides; therefore, care must be taken when treating sensitive crops during periods when plants are subjected to drought stress, high temperatures and high humidity.

## DIRECTIONS FOR USE

Shake or agitate well before each use. Rates of RNA TIMBER may vary with the conditions of application. Always provide good agitation when adding RNA TIMBER to the spray mixture. Always add RNA TIMBER last to the spray mixture.

**GENERAL:** Use 1-2 pints of RNA TIMBER per acre. The high end of the recommended use rate may be necessary during periods when plants are subjected to extreme stress or weed populations. The addition of a liquid fertilizer (28-32% nitrogen solution) may also be required to improve control under extreme environmental conditions such as drought, high heat, or high humidity. Always follow the adjuvant use recommendations as shown on the pesticide label.

**BACKPACK AND HANDHELD SPRAYERS:** For handgun or backpack applications, do not exceed a rate of 5% volume/volume. Follow the use rates and recommendations that are shown on the pesticide label.

For pesticides that permit use of an adjuvant at a higher rate, follow instructions on that pesticide label. However, do not add this product at a rate which exceeds 5% of the finished spray volume, except when used as a diluent in dormant, basal, site preparation or other similar applications, per label instructions. Use caution at the higher use rates. When applying to a sensitive crop, first treat a small area to determine if there are any adverse effects to the crop.
