GENERAL INFORMATION

SERENITY® PLUS is designed to enhance the performance and provide general drift control of various post-emergence herbicides, including products used on crops containing auxin genetic traits and tank mixes that include the herbicides, XtendiMax®, Engenia®, and/or FeXapan™. Many post-emergence herbicides such as glyphosate perform best when a water quality product, such as SERENITY PLUS is used in the tank mix to mitigate water hardness issues.

SERENITY PLUS may be used with all approved dicamba tank mixes where the addition of a water quality adjuvant and deposition aid have shown to improve performance of the active ingredients. SERENITY PLUS replaces the need for any other water conditioner and may be used with products and tank mixes that contain the active ingredient, dicamba.

NOTE: SERENITY PLUS does not replace the need for additional adjuvants/surfactants in the spray tank.

DIRECTIONS FOR USE

Shake well before use. Rates of SERENITY PLUS may vary with the conditions of application. Fill spray tank one half (1/2) full with water. Add the proper amount of SERENITY PLUS and pesticide. Add the remainder of the water. Bypass agitation is sufficient when using SERENITY PLUS, but it should continue until all of the spray mixture has been sprayed.

USE RATES

For all tank mixes that contain XtendiMax, Engenia and/or FeXapan, use 5 pints of SERENITY PLUS per 100 gallons of spray mix.

For all other tank mixes depending on water hardness, use 2-4 quarts of SERENITY PLUS per 100 gallons of spray mix. The use rates for improving tank mix water quality are:

- Up to 500 ppm hardness – 2 quarts per 100 gallons
- 500 to 750 ppm hardness – 3 quarts per 100 gallons
- 750 ppm hardness – 4 quarts per 100 gallons

For pesticides that permit use of an adjuvant at a higher rate, follow instructions on that pesticide label. However, do not add this product at a rate which exceeds 5% of the finished spray volume, except when used as a diluent in dormant, basal, site preparation or other similar applications, per label instructions. Use caution at the higher use rates. When applying to a sensitive crop, first treat a small area to determine if there are any adverse effects to the crop.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PRODUCT STORAGE: Store in original container only and keep tightly closed. Store in closed storage areas. Use caution when moving, opening, closing or pouring.
