### GENERAL INFORMATION

Many post-emergence herbicides such as glyphosate perform best when a water quality product, such as SERENITY®, is used in the tank mix to mitigate water hardness issues.

SERENITY replaces the need for any other water conditioner and may be used with products and tank mixes that contain dicamba.

## DIRECTIONS FOR USE

Shake well before use. Rates of SERENITY may vary with the conditions of application. Fill spray tank one half (1/2) full with water. Add the proper amount of SERENITY and pesticide. Add the remainder of the water. Bypass agitation is sufficient when using SERENITY, but it should continue until all of the spray mixture has been sprayed.

## USE RATES

SERENITY is designed to improve the performance of various post-emergence herbicides, including products used on auxin genetic crops and tank mixes that contain dicamba herbicide where a water quality adjuvant is required.

**GENERAL:** Use 2-4 quarts of SERENITY per 100 gallons depending on water hardness:

- Up to 500 ppm hardness – 2 quarts
- 500 to 750 ppm hardness – 3 quarts
- 750 ppm hardness – 4 quarts

**AQUATICS:** SERENITY may be used as an additive with aquatically labeled pesticides. Follow the use directions and adjuvant rates that are shown on the pesticide manufacturer's label.

For pesticides that permit use of an adjuvant at a higher rate, follow instructions on that pesticide label. However, do not add this product at a rate which exceeds 5% of the finished spray volume, except when used as a diluent in dormant, basal, site preparation or other similar applications, per label instructions. Use caution at the higher use rates. When applying to a sensitive crop, first treat a small area to determine if there are any adverse effects to the crop.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

**PRODUCT STORAGE:** Store in original container only and keep tightly closed. Store in closed storage areas. Use caution when moving, opening, closing or pouring.
