GENERAL INFORMATION

Shackle is farmer tested and a scientifically approved alternative to traditional methods of conditioning water where volatility is a concern. Shackle is a premium Non-AMS water conditioner which chelates the metallic ions found in hard water thereby giving farmers a safe option to apply herbicide without volatility drift. HANDLING AND STORAGE

Do not breathe mist, vapors. Wash hands, forearms and face, clothing thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear eye protection, protective clothing, protective gloves. Absorb spillage to prevent material damage. Store locked up. Store in corrosive resistant container with a resistant inner liner. Dispose of contents/container to a licensed hazardous-waste disposal contractor or collection site except for empty clean containers which can be disposed of as non-hazardous waste.

DIRECTIONS FOR USE

- Always add Shackle to water before adding glyphosate.

FIRST AID

If on skin: Wash with plenty of soap and water. **IF INHALED:** Remove person to fresh air and keep comfortable for breathing. **IF IN EYES:** Rinse cautiously with water for several minutes.
