GENERAL INFORMATION

APPLICATION TO TURFGRASS

The use of this product will provide plant nutrients as well as providing control of selected insect pests. ALLECTUS 0.225 PLUS TURF FERTILIZER can be used for the control of soil inhabiting pests of turfgrass, such as northern and southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; black vine weevil, Otiorhyncus sulcatus, European chafer, Rhizotrogus majalis; green June beetle, Cotinis nitida; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia japonica, oriental beetle, Anomala orientalis, Euetheola humulis rugiceps, billbugs, Sphenophorus spp.; annual bluegrass weevil, Hyperodes spp.; black turfgrass ataenius, Ataenius spretulus; Aphodius spp; European crane fly, Tipula paludosa; frit fly, Oscinella frit; chinch bugs, Blissus spp.; fire ants, Solenopsis spp.; cutworms, Agrotis ipsilon, Peridroma saucia, Nephalodes menians, armyworms, Spodoptera spp., Pseudaletia spp.: sod webworm. Crambus spp.: and mole crickets. Scapteriscus spp. ALLECTUS 0.225 PLUS TURF FERTILIZER can be used as directed on turfgrass in sites such as home lawns, business and office complexes, shopping complexes, multi-family residential complexes, airports, cemeteries, parks, playgrounds, and athletic fields.

The active ingredients ALLECTUS 0.225 PLUS TURF FERTILIZER have sufficient residual activity so that applications for control of subsurface feeders can be made preceding the egg laying activity. The need for an application for control of subsurface feeders can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control of subsurface feeders will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

The active ingredients in ALLECTUS 0.225 PLUS TURF FERTILIZER have sufficient knockdown and residual activity to provide curative and residual control of surface feeding pests. Applications for control of surface feeding pests can be made when infestations are anticipated based on historical monitoring of the site, previous records or experience, current season adult trapping or presence of insects at economic thresholds as deter-

Do not apply more than 200 lb. of ALLECTUS 0.225 PLUS TURF FERTILIZER (0.25 lb. of imidacloprid, 0.2 lb. bifenthrin) per acre per application on residential use sites (i.e., around private homes, apartment buildings, condominiums, non-agricultural outbuildings, non-commercial greenhouses, pre-schools or day care facilities). May be applied at up to 400 lb. of ALLECTUS 0.225 PLUS TURF FERTILIZER (0.5 lb. of imidacloprid, 0.4 lb. bifenthrin) per application on non-residential use sites (i.e., around institutional, public, commercial or industrial buildings; parks; recreational areas or athletic fields).

APPLICATION EQUIPMENT

Apply ALLECTUS 0.225 PLUS TURF FERTILIZER uniformly over the area being treated with normally used granular application equipment. Both drop-type and rotary-type spreaders may be used to apply ALLECTUS 0.225 PLUS TURF FERTILIZER. Avoid the use of spreaders that apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately.

NOTE: For optimum control, irrigation or rainfall should occur within 24 hours after application to move the active ingredient through the thatch. Do not apply more than 400 lb product (0.5 lb of imidacloprid active ingredient, 0.4 lb bifenthrin) per acre per year. Do not apply more than 200 lb product (0.25 lb imidacloprid, 0.2 lb bifenthrin) per acre per application to residential turf. Avoid mowing turf or lawn area until after irrigation or rainfall has occurred so that uniformity of application will not be affected.

In New York State, this product may NOT be applied to any grass or turf area within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch).

In New York State, make a single repeat application of ALLECTUS 0.225 PLUS TURF FERTILIZER if there

are signs of renewed insect activity, but not sooner than two weeks after the first application.

¹Imported Fire ants: ALLECTUS 0.225 G Plus Turf Fertilizer may be applied as a broadcast treatment in nonresidential turf areas up to 9.2 lb. per 1000 sq. ft. For mound treatment, apply 3/4 cup ALLECTUS 0.225 G Plus Turf Fertilizer per mound and then drenching the mound with 1 to 2 gallons of water. The mounds should be treated with sufficient force to break their apex and allow the insecticide to flow into the ant tunnels.

²Mole crickets: For maximum effectiveness, apply ALLECTUS 0.225 PLUS TURF FERTILIZER as a broadcast treatment at 4.6 lb. per 1000 sq. ft. prior to or during the peak egg hatch period. For application when both adults and/or large nymphs are present and actively tunneling, irrigate prior to application if soil is dry and apply 4.6 lb. per 1000 sq. ft. Rainfall or additional irrigation within 24 hours after application will improve effectiveness of ALLECTUS 0.225 PLUS TURF FERTILIZER. For heavily infested mole cricket areas, use a single seasonal application rate of 320 to 400 lb per acre in non-residential turf.

³Pillbugs and sowbugs: For heavy infestation use 400 lbs per acre (9.2 lbs per 1000 sq. ft.) of ALLECTUS 0.225 G Plus Turf Fertilizer in non-residential turf.

Do not apply more than 400 lb (0.5 lb of irridacloprid and 0.4 lb of bifenthrin) per acre per vear.

Treated areas may be replanted with any crop specified on an imidacloprid and a bifenthrin label, or with any crop for which a tolerance exists for the two active ingredients.
