FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

GENERAL INFORMATION:

DRACO® is fortified with Ecklonia Maxima Kelp Extract, calcium nitrate, calcium acetate, and brewer's yeast to help plants overcome stress and is utilized during metabolic activity. With programmed use, turf will express a natural ability to withstand external stresses more effectively. DRACO's neutral pH and low salt index makes it extremely safe on fine turf and more compatible with tank mixing.

DIRECTIONS FOR USE:

Tees and Greens: Apply 3 to 6 ounces per 1000 sq. ft. every 7 to 21 days as needed.

Fairways: Apply 1 - 2 gallons per acre in a minimum of 50 gallons of water. During times of stress, application intervals may be increased based on desired results

ORNAMENTALS

Apply 1 gallon per 100 gallons or 1 gallon per acre using no less than 20 gallons of water.

STORAGE and DISPOSAL

STORAGE: Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures.
