### APPLICATION RECOMMENDATIONS

Application rate depends on soil test results. In the absence of soil test results use the following application rate:

- To maintain soil pH and optimum growing conditions, apply Signature® Enriched Hi-Cal Limestone Powered by Titan® XC at 6 lbs/1,000 sq ft or 260 lbs/acre. Two applications a year are recommended.  
**(50 lb bag covers 8,250 sq ft)**
- To adjust pH, apply Signature® Enriched Hi-Cal Limestone Powered by Titan® XC at 12 lbs/1,000 sq ft or 520 lbs/acre, or as needed. Multiple applications may be necessary after retesting.  
**(50 lb bag covers 4,150 sq ft).**

### WATER IN THOROUGHLY

### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
