Most effective weed control will be obtained when this product is activated by at least 0.5 inches of rainfall or irrigation, or with shallow (1 to 2 inches) incorporation, prior to weed seed germination and within 14 days following application.



The maximum amount of this product that may be applied per year is given for each turf grass species in the **Maximum Annual Rates** section of this label. Most effective weed control in turf grasses will be obtained when this product is activated by at least 0.5 inches of rainfall or irrigation prior to weed seed germination and within 14 days following application.

#### **Use Precautions**

The following precautions apply to the use of this product in turf grasses and lawns: Application of this product may thin emerged annual bluegrass and newly overseeded grasses.

Do not apply to overseeded turf within 60 days after seeding or until after the second mowing, whichever is longer. Injury to desirable seedlings is likely if this product is applied before seedling secondary roots are in the second inch of soil, not thatch plus soil.

Do not cut (harvest) treated sod before 120 days after application. Do not apply to newly set sod until the following year.

Application of this product to turf stressed by drought, low fertility, or pest damage may result in turf injury.

Disturbing the herbicide barrier with cultural practices such as disking may result in reduced weed control.

Do not apply this product to putting greens or areas where dichondra, colonial bentgrass, velvet bentgrass or annual bluegrass (*Poa annua*) are desirable species.

#### **Rates of Application**

This product may be applied as a single application or in sequential applications to control weeds germinating throughout the year. All applications must be made prior to germination of the target weeds. This product will not control established weeds.

Maximum use rate selection should be based on turf species. The length of time of residual weed control provided by this product is related to the rate applied.

#### Maximum Annual Rates

This product is recommended for use on the turf grass species listed in the following table. Do not exceed the maximum yearly rate as given in the following table:

- 2) May be used on newly sprigged or plugged Bermudagrass at rates not to exceed 260 lbs/A. Newly sprigged or plugged Bermudagrass stolon rooting may be temporarily retarded. Suppression only of Foxtail, Goosegrass and Rescuegrass due to reduced product rates used in sprigging situations.
- Do not apply more than 750 lbs of this product per calendar year.

In many areas a single application of 330 to 750 lbs/A of this product will control goosegrass. However, under heavy goosegrass pressure and/or an extended growing season, most effective weed control may be obtained by making an initial application of 330 to 500 lbs/A followed after 60 to 90 days by a second application at doses that would not exceed those given in the Maximum Annual Rate Table. Do not exceed the maximum rate for turf grass species listed in the **Maximum Annual Rate Table** above.

Applications for this weed should be made in late summer, fall or winter prior to germination. Suppression only.

Sequential applications may be made so long as the total amount of product applied does not exceed the maximum annual application rates recommended for each turf species. All applications must be made prior to germination of the weed seeds.

#### WHEN TO APPLY AFTER OVERSEEDING TURF

Do not apply to overseeded turf within 60 days after seeding or until after the second mowing, whichever is longer. Injury to desirable seedlings is likely if this product is applied before seedling secondary roots are in the second inch of soil, not thatch plus soil.

#### WHEN TO OVERSEED AFTER APPLICATION

This product will inhibit the germination of turf species if overseeded too soon after application. Follow rates and intervals in the table below for best overseeding/reseeding results.

LANDSCAPE ORNAMENTALS

(including Established Perennials and Wildflower Plantings)

This product may be applied for residual preemergence weed control in ornamentals.

#### Use Rates

Apply this product at 330 to 750 lbs/A in fall and/or spring. Use higher rates of application for longer control periods. Sequential or single applications are allowed so long as the total amount of product applied does not exceed the maximum annual application rate of 750 lbs/A/yr.

#### Application Timing and Information

This product is a preemergence herbicide and will not control emerged weeds. Most effective weed control in ornamentals will be obtained when this product is activated by at least 0.5 inches of rainfall or irrigation, or with shallow (1 to 2 inches) mechanical incorporation, prior to weed seed germination and within 14 days following application. Best weed control is obtained when this product is applied to soil free of clods, weeds, and debris such as leaves. Prior to application of this product, control existing vegetation by hand weeding, cultivation, or the use of an appropriate postemergence herbicide.

#### Established Landscape Ornamentals

This product may be applied to established ornamentals as a broadcast, over the top or directed application. Irrigation or rainfall soon after application will wash residues off plant foliage and activate this product in the soil.

#### Newly Transplanted Landscape Ornamentals

This product may be applied to newly transplanted ornamentals as a broadcast, over the top or directed application. Delay application to allow soil to settle around new transplants and water thoroughly before applying this product. Apply this product after cuttings form roots and become established. Apply before budding/grafting or after buds/grafts have taken to avoid any inhibition of the tissue union.

#### **Tolerant Ornamental Species**

This product will not harm most trees, shrubs, vines and flowers. Best results will be obtained when this product is uniformly applied to the soil surface; avoid applying to ornamental shoots which may defeat the effort to get uniform distribution on the soil surface. This product may be applied over the top of species. When plants are under stress (such as heat, drought, or frost damage) some cultivars of plants may be sensitive to this product.

Do not use on food producing trees, vines, or plants. Not for use on container grown plants.
