**STEPUP® 2.0** is a highly soluble formulation comprised of protein hydrolysate obtained from the bio-fermentation process of proteins and amino acids. **STEPUP 2.0** supplements seed exudates that are released from the imbibing seed during the early stages of germination. **STEPUP 2.0** does not contain plant hormones or synthetic chemicals.

#### **DIRECTIONS FOR USE**

**STEPUP 2.0** is recommended to be an additive to current standard seed treatments and is not intended to be used alone. Shake well before using. Use 0.5-1.0 fluid ounce of **STEPUP 2.0** per 100-weight (cwt) of seed.

**STEPUP 2.0** is believed to be compatible with most agricultural, water-soluble, seed treatment crop protection products. If physical compatibility with other products is unknown, use a jar test to test for compatibility.
