STEPUP™ is a highly soluble formulation comprised of protein hydrolysate obtained from the bio-fermentation process of proteins and amino acids. **STEPUP** supplements seed exudates that are released from the imbibing seed during the early stages of germination. **STEPUP** does not contain plant hormones or synthetic chemicals.

DIRECTIONS FOR USE

STEPUP is recommended to be an additive to current standard seed treatments and is not intended to be used alone. Shake well before using. Use 1-2 fluid ounces of **STEPUP** per 100-weight (cwt) of seed.

STEPUP is believed to be compatible with most agricultural, water-soluble, seed treatment crop protection products. If physical compatibility with other products is unknown, use a jar test to test for compatibility.
