STEPUP™ SP is designed for small grains and pulse crops. It is a highly soluble formulation comprised of soy protein hydrolysate obtained by the hydrolysis of proteins to their constituent amino acids and short polypeptides. STEPUP SP supplements seed exudates that are released from the imbibing seed during the early stages of germination. STEPUP SP does not contain plant hormones.

DIRECTIONS FOR USE

STEPUP SP is recommended to be an additive to current standard seed treatments and is not intended to be used alone. Shake well before using. Use 1-2 fluid ounces of STEPUP SP per 100-weight (cwt) of seed.

COMPATIBILITY

STEPUP SP is believed to be compatible with most agricultural, water-soluble, seed treatment crop protection products. If physical compatibility with other products is unknown, use a jar test to test for compatibility.
