STEPUP® Zn is a liquid micronutrient product containing 9.0% zinc, formulated with both EDTA and IDS chelates for maximum stability and effectiveness. **STEPUP Zn** is designed for small grains and pulse crops. It can also be used on corn, sorghum and cotton.

DIRECTIONS FOR USE

STEPUP Zn is recommended to be an additive to current standard seed treatments and is not intended to be used alone. Shake well before using. Use 2-6 fluid ounces of **STEPUP Zn** per 100-weight (cwt) of seed.
