- For best results apply as a foliar spray in the early morning when temperatures are lowest.
- Do not apply water for 4 to 6 hours to ensure plant uptake.
- For severe iron deficiencies apply the highest rate.
- Application time on cool season turf should be done when temperatures are below 80 degrees.
- Turf grasses: Apply 2-6oz/1000 sq. ft. on all types of turf depending on the deficiency.
