PRODUCT INFORMATION

StrongSide™ is a premium nonionic surfactant. It functions as a spreader and activator, which effectively wets and spreads various pesticides onto a leaf's surface. StrongSide can increase absorption and translocation of systemic pesticides into and within the plant.

Environmental conditions may affect the performance of StrongSide and care should be exercised when deciding on a rate. In hot, dry weather and conditions where weeds are under stress, use a higher rate to increase the performance of herbicides.

NOT FOR AQUATIC USE IN WASHINGTON.

NOTE: StrongSide should be added as the last product in the tank mix unless otherwise directed by a pesticide label.

USE RATES

ACARICIDES, FUNGICIDES AND INSECTICIDES: Use 8-32 fluid ounces of StrongSide per 100 gallons of spray mix.

HERBICIDES: Use 6-48 fluid ounces of StrongSide per 100 gallons of spray mix.

BACKPACK OR HANDHELD SPRAYERS: Use 1-2 tablespoons (1/2-1 fluid ounces) of StrongSide per gallon of spray mix.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store in original container only and keep tightly closed. Store in closed storage areas. Use caution when moving, opening, closing or pouring.
