### GENERAL INFORMATION

SUPER SPREAD® 90 is a general purpose nonionic surfactant used for increasing the efficiency of various agricultural chemicals. It should be used where quick wetting and uniform distribution of the pesticide are required.

SUPER SPREAD 90 application rates may vary with the conditions of application. Use just enough to form a uniform film. Always add as the last ingredient to the spray tank with the agitator running. If excessive foaming occurs, add a defoaming agent.

When application plans include the use on a sensitive crop, it is recommended that a small area first be treated, to determine if there may be any adverse effects on the crop.

## SUGGESTIONS FOR USE

Defoliants	1-2 pts.	or	16-32 oz.
Desiccants	1-2 pts.	or	16-32 oz.
Fungicides	1/4-3/4 pts.	or	4-12 oz.
Insecticides	1/2-1 pts.	or	8-16 oz.
Herbicides	1/2-3 pts.	or	8-48 oz.
Miticides	1/4-3/4 pts.	or	4-12 oz.

Variations in conditions of use can cause some variation in the amount of SUPER SPREAD 90 required. The minimum required to give a smooth, uniform coverage usually gives the most effective results.

## MIXING INSTRUCTIONS

For wettable powders and water soluble materials, add SUPER SPREAD 90 to water before adding pesticide to spray tank. For emulsifiable products, add SUPER SPREAD 90 after a good emulsion is formed.
