

RECOMMENDED APPLICATIONS

Row Crops/Forage Crops/Turf Farms:

- Apply 1 to 2 quarts per acre
 - ◆ Preplant or at planting: Apply and incorporate into the soil.
 - ◆ Post-emergence up to fruiting stage: Foliar feed/side-dress.
 - ◆ Post-grazing: Immediate application to soil.
- Can be tank mixed with fertilizer.
- Soil application mix with minimum of 10 gallons of water.
- Foliar application mix with minimum of 10 to 100 gallons of water.

Permanent Crops:

- Soil or Foliar: 1/2—2 gallons per acre mixed with 10-100 gallons of water at bloom and fruit set.
- Product can be applied through irrigation (drip/flood/spray/etc.).

FOR BEST RESULTS IN AGRICULTURAL APPLICATION:

- Ensure tank is free of residue, if using chlorinated water, let tank sit for 24 hrs (with lid removed) before mixing.
- Do not apply when a crop is severely stressed.
- Can be mixed with most fungicides.
- Consult dealer for insecticide compatibility.
- May be mixed with a herbicide.

Use only as directed on the label.
Shake well before using.
Keep out of the reach of children.

Eye Contact: Flush with water/call physician.

Skin Contact: Exposure may result in dry skin. Rinse/Apply lotion.
