Hazards to Humans and Domestic Animals

Important: Do not expose children, pets, or other nontarget animals to rodenticides. To reduce exposure:

- Store product not in use in a location out of reach of children and pets.
- When used in residential structures, this product must be applied in tamper-resistant bait stations. All above-ground, outdoor applications must be in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hooved livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
- Dispose of product container, and unused, spoiled, and unconsumed bait as specified on this label.

Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait.

USE RESTRICTIONS

This product may only be used to control Norway rats, roof rats, and house mice *in and within* 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food-processing facilities, industrial and commercial buildings, trash receptacles, transport vehicles (ships, trains, aircraft), docks, and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting beyond 100 feet from a structure as defined above is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait.

Do not use in sewers. Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food- or feed-handling equipment, milk- or meat-handling equipment, or surfaces that come into direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not broadcast bait.

Burrow baiting with Talon-G Rodenticide Bait Pack Mini-Pellets is prohibited.

Do not sell this product in individual containers holding less than 16 pounds of bait.

SELECTION OF TREATMENT AREAS

Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

APPLICATION DIRECTIONS

Norway and Roof Rats

Apply 4–16 bait packs (usually at intervals of 15–30 ft.) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

House Mice

Apply 1 bait pack per placement. Space placements at intervals of 8–12 ft. Two bait packs may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Follow-Up

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead rodents and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. Where a continuous source of infestation is present, maintain permanent bait stations and replenish with census or toxic bait as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage



Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

Pesticide Disposal

Dispose of wastes resulting from the use of this product at an approved waste disposal facility or call your local solid waste agency for alternative disposal instructions. Never place unused product down any indoor or outdoor drain.
