Mixing Procedures

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. Agitation is necessary for proper dispersal of the product. - 1. For groundboom and aerial applications, use only medium or coarser spray nozzles according to ASABE (S572) definition for standard nozzles. Aerial applicators must consider flight speed and nozzle orientation in determining droplet size.
- Make aerial or ground applications when the wind velocity is 3 to 10 mph. Do not apply when the wind speed is greater than 10 mph. For all non-aerial applications, wind speed must be measured adjacent to the application site on the upwind side, immediately prior to application.

Maximum Use Rates

For turfgrass, up to 345 fl oz of TARTAN FUNGICIDE can be applied per acre per year.

For turfgrass, maximum single application rate is 2.7 lb ai/A. (triadimefon).

TURFGRASS DISEASE CONTROL
