DIRECTIONS FOR USE

1. Start with a clean spray tank.
2. Fill the spray tank $\frac{1}{2}$ - $\frac{3}{4}$ full of water.
3. While continuing to fill with water add water conditioning product and/or Ammonium Sulfate at recommended rates
4. Add Tetra-Bor® 10
5. Add herbicide, pesticide or other fertilizer
6. Fill remainder of tank and agitate

Note: All micronutrient additives have the potential to cause antagonism of glyphosate herbicides. A quality water conditioner and/or ammonium Sulfate is recommended to help to alleviate antagonism potential.

Excessive use of Boron containing products may cause boron toxicity on some crops. Do not exceed recommended rates of Boron for the crop that this product is being applied.

FIRST AID
