GENERAL INFORMATION

TILL-IT® 12% HUMIC ACID solution may be applied to most crops. This product is readily dispersed in most fertilizer or micronutrient products. Avoid using this product with acids and oxidizers.

This product is a weak alkaline solution and may alter the pH of certain solutions. A weak acid may be used to reduce the pH of the spray solution. This product may be applied with various irrigation water systems.

DIRECTIONS FOR USE

DOSAGE

FOLIAR: Apply 1-3 quarts per acre with sufficient water for thorough coverage. Apply this product by air or ground application. This product is a weak alkaline salt and may be neutralized with a buffer. High rates of this product in combination with high rates of other materials may cause burn. When in doubt test this product on a small scale.

TURF: Apply 8-16 ounces per 1,000 sq. ft. with sufficient water for thorough coverage.

SOIL: Apply 1-12 quarts per acre with fertilizer or with water. This product may require agitation when mixed in concentrated phosphate
