TILL-IT® BACKBONE® is designed for below seed row placement prior to planting to provide phosphate in a readily available form to strengthen early seedling growth and enhance stand uniformity.

TILL-IT products should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield, and quality.

DIRECTIONS FOR USE

Apply TILL-IT BACKBONE using recommended rates and directions. Moisture conditions and planting strategy are important considerations when using TILL-IT BACKBONE. Apply total material 4-6 inches directly beneath where the seed shall be placed in a band, or utilizing a 3-winged vertical drench shank. Pre-irrigate prior to planting unless adequate rainfall will provide proper moisture conditions at time of planting.

ROW CROPS: Apply 6-15 gallons/acre banded as described above.

OTHER CROPS: Apply 6-30 gallons per acre as a band or pre-plant application.
