GENERAL INFORMATION

TILL-IT BACKBONE LIVE 6-21-0 is designed for below seed row placement prior to planting to provide phosphate in a readily available form to strengthen early seedling growth and enhance stand uniformity. This product contains humic acids which may increase micronutrient uptake. It should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

Moisture conditions and planting strategy are important considerations when using TILL-IT BACKBONE LIVE 6-21-0.

CORN STARTER APPLICATION: Use 5-15 gallons per acre as a band directly below and to the side of the seed. It may also be applied as a surface spray band over the top or to the side of the seed prior to planting.

POP-UP APPLICATION: Use 3-5 gallons per acre on seed as established by local practices. On dry soils, post-irrigation within 24 hours is highly recommended. It is not recommended to apply directly to seed on saline soils.

OTHER CROPS PREPLANT: Use 5-30 gallons per acre as a band or broadcast.

COMPATIBILITY: This product is not compatible with acid fertilizers. Compatibility with other products may vary. Always jar test new combinations for compatibility prior to field mixing. Do not mix with calcium fertilizers. Consult with your local Wilbur-Ellis representative for further information.
