## GENERAL INFORMATION

TILL-IT CARBO-ZINC 8-0-0 is designed primarily for soil applications to prevent or correct zinc deficiencies in a wide range of agronomic plants. Application of this product is a means of obtaining a quick response to needed elements. It is effective under adverse soil conditions unlike inorganic zinc compounds that are tied up and unavailable to the plant. These adverse conditions include: high phosphate soil levels, high pH (alkaline), high salinity, high carbonate levels, and clay soils (adsorption).

This product should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

## DIRECTIONS FOR USE

**SOIL:** Apply with pesticide, fertilizer, or irrigation water (drip, overhead, or emitter) at 1-6 quarts per acre. It may be applied preplant (as near as possible to planting) or during planting (close to the seed).

### NOT INTENDED FOR FOLIAR USE.

**COMPATIBILITY:** This product can be applied alone or with compatible agricultural chemicals. Proposed mixtures should be evaluated in a jar test before full scale use. TILL-IT CARBO-ZINC 8-0-0 is not compatible with high orthophosphate fertilizers nor acid-based fertilizers such as combinations of phosphoric, sulfuric, and urea-phosphoric acid solutions.
