### DIRECTIONS FOR USE

**POP-UP APPLICATIONS:** Apply 1-4 quarts per acre with the desired pop-up fertilizer to be applied on seed as established by local agricultural practices. Use caution when applying to small-seeded crops such as bluegrass, canola, rape and mustard as well as soybeans, and use rates of 1-2 quarts on these sensitive crops. It is generally advised that starter fertilizers including those containing **TILL-IT CAST IRON PREMIX** be placed no closer than 2 inches from the seed on sensitive crops. **TILL-IT CAST IRON PREMIX** may be diluted with water for ease of calibration if needed. When applied in the seed furrow on very dry soils, a post plant irrigation within 24 hours is recommended. Use CAUTION when applying directly to the seed in very saline soils as there may be a risk of seedling injury.

**STARTER APPLICATIONS:** Apply 0.5-2 gallons per acre with the desired starter fertilizer as a band directly below the seed or 1-2 gallons below and to the side of the seed line. **TILL-IT CAST IRON PREMIX** may also be applied as a surface spray band over the top or to the side of the seed prior to planting. Use caution when applying to small-seeded crops such as bluegrass, canola, rape and mustard as well as soybean. It is generally advised that starter fertilizers including those containing **TILL-IT CAST IRON PREMIX** be placed no closer than 2 inches from the seed on sensitive crops.

**FOLIAR APPLICATIONS:** **TILL-IT CAST IRON PREMIX** may be applied at 1-2 quarts per acre alone or combined with other foliar nutrients as needed. When applying through a conventional ground sprayer a minimum of 20 gallons of water per 1 quart of **TILL-IT CAST IRON PREMIX** is recommended. When applying in low volume spray equipment, a maximum rate of 1 quart per acre is recommended. Burning may occur in low volume sprays.

The compatibility of **TILL-IT CAST IRON PREMIX** with other products may vary. Always jar test new combinations for compatibility prior to field mixing.
