TILL-IT® EZ-FLOW® should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

For use with in-furrow applications of starter and pop-up fertilizers, use 24-32 fluid ounces of **TILL-IT EZ-FLOW** per acre mixed with starter fertilizers to provide essential micronutrient plant nutrition. When Emulsifiable Concentrate (EC) or Suspension Concentrate (SC) pesticide products are to be added to the starter or pop-up fertilizer, adhere to the following mixing instructions:

EMULSIFIABLE CONCENTRATES: For EC formulations, blend the proper per acre rate of the EC pesticide directly with 24-32 fluid ounces per acre of **TILL-IT EZ-FLOW.** Add this premix to starter fertilizers including UAN solutions or high orthophosphates such as 6-24-6. Some mixing, such as bypass agitation or eductor stream addition, will improve the quality of the blend.

SUSPENSION CONCENTRATES: For SC pesticide formulations, dilute the proper per acre rate of SC pesticide with 1 gallon of water per acre and then add 24-32 fluid ounces per acre of **TILL-IT EZ-FLOW**.
