TILL-IT GRAND SLAM should be used as part of a comprehensive Total Nutrition System for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

Apply TILL-IT GRAND SLAM using recommended rates and directions with your nutrient management plans. TILL-IT GRAND SLAM can be applied via broadcast, banding, or injection on all row crops and permanent crops. Placement 2-4 inches below and to the side of seed placement is recommended, do not apply TILL-IT GRAND SLAM directly on seed.

ROW CROPS: Apply 5-70 gallons per acre, as a broadcast, injection, or through irrigation. Incorporation is recommended.

OTHER CROPS: Apply 5-50 gallons per acre, as a broadcast, drip-injection, or band. Incorporation is recommended.

COMPATIBILITY

Do not mix TILL-IT GRAND SLAM with calcium fertilizers or with low pH solutions. Avoid storing in direct sunlight. Always jar test new combinations for compatibility prior to field mixing.
