### GENERAL INFORMATION

TILL-IT® GREEN-ZONE® is a low salt index, liquid phosphate fertilizer designed as a starter or pop-up fertilizer.

TILL-IT GREEN-ZONE may be applied below, to the side or in the seed furrow of most crops depending on local conditions and established agricultural practices. TILL-IT GREEN-ZONE contains fully chelated EDTA zinc for enhanced micronutrient uptake. TILL-IT products should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield, and quality.

### DIRECTIONS FOR USE

Moisture conditions and planting strategies are important considerations when using TILL-IT GREEN-ZONE.

**POP-UP APPLICATIONS:** Apply 1-5 gallons per planted acre on seed as established by local agricultural practices. TILL-IT GREEN-ZONE may be diluted with water for ease of calibration if needed. When applied in the seed furrow on very dry soils, a post plant irrigation within 24 hours is recommended. Use caution when applying directly to the seed in very saline soils as there may be a risk of seedling injury.

**STARTER APPLICATIONS:** Apply 1-8 gallons per acre as a band directly below the seed or 5-20 gallons below and to the side of the seed line.

TILL-IT GREEN-ZONE may also be applied as a surface spray band over the top or to the side of the seed prior to planting. Bluegrass, canola,

rape, mustard, soybeans, and other small seed crops should have TILL-IT GREEN-ZONE placed no closer than 2 inches from the seed.

**FOLIAR APPLICATIONS:** TILL-IT GREEN-ZONE may also be used as foliar spray at 2-4 quarts for row and field crops and 2-8 quarts for tree crops. Apply in a minimum of 5 gallons of water for every 2 quarts of TILL-IT GREEN-ZONE.

TILL-IT GREEN-ZONE can be applied through center pivot or drip irrigation systems, but check your water source prior to application for calcium or other impurities. Always jar test with water source for precipitation prior to actual field use.

### COMPATIBILITY

TILL-IT GREEN-ZONE is not compatible with acid fertilizers. Compatibility with other products may vary. Always jar test new combinations for compatibility prior to field mixing. Do not mix with calcium fertilizers.
