### DIRECTIONS FOR USE

**1<sup>st</sup> YEAR ORCHARDS:** Apply 0.5 ounce per tree, should treat 1,600 trees per 50-pound bag.

**2<sup>nd</sup> YEAR ORCHARDS:** Apply 1 ounce per tree, should treat 800 trees per 50-pound bag.
