**GENERAL INFORMATION**

TILL-IT® K-SOLVE™ is designed primarily for soil applications to prevent or correct potassium and sulfur deficiencies in a wide range of crops. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Application of this product is a means of obtaining a quick response to needed elements. TILL-IT K-SOLVE should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

**DIRECTIONS FOR USE**

TILL-IT K-SOLVE may be applied on all tree, vine, field, row or vegetable crops by ground or fertigation application. Timing of treatments should be based on crop nutrient demand, prevailing environmental conditions, plant tissue analysis data or other information that indicates a need for supplemental potassium and sulfur.

**SOIL APPLICATION:**

Apply 1-3 gallons per acre at planting. If blending with UAN, use at a ratio of 1 part TILL-IT K-SOLVE to 4 parts UAN.

**FERTIGATION APPLICATION:**

Apply 0.5-5 gallons per acre. Multiple applications can be beneficial.

**COMPATIBILITY:** TILL-IT K-SOLVE may be blended with other fertilizers to provide important nutrients needed to grow high-yielding crops. Proposed mixtures should be evaluated in a jar test before full scale use. Primarily, it should be blended with UAN solutions for sidedress and/or fertigation application. This product contains a proprietary additive which allows for more narrow mixing ratios with UAN solutions than other potassium products currently on the market.

**CAUTION WHEN MIXING WITH UAN:** The temperature of UAN and storage time can influence successful mixing of the final solution.
