GENERAL INFORMATION

TILL-IT® PERFECTO® is a liquid phosphate fertilizer designed as a starter or pop-up fertilizer. It may be applied below, to the side or in the seed furrow of most crops depending on local conditions and established agricultural practices. This product contains fully chelated EDTA zinc and manganese.

TILL-IT PERFECTO should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield, and quality.

DIRECTIONS FOR USE

Before application, consider the total salt index, soil type, moisture level and rate of fertilizer application when using TILL-IT PERFECTO.

POP-UP APPLICATIONS: Apply 1-5 gallons per planted acre on seed as established by local agricultural practices. This product may be diluted with water for ease of calibration if needed. When applied in the seed furrow on very dry soils, a post plant irrigation within 24 hours is recommended. Use caution when applying directly to the seed in very saline soils as there may be risk of seedling injury.

STARTER APPLICATIONS: Apply 1-5 gallons per acre as a band directly below the seed or 5-20 gallons 2 inches below and to the side of the seed line. TILL-IT PERFECTO may be diluted with water or UAN in 2x2 applications for ease of calibration if needed. It may also be applied as a surface spray band over the top or to the side of the seed prior to planting.

APPLICATIONS FOR SMALL SEED CROPS (including Bluegrass, Canola, Rape, Mustard): Place this product no closer than 2 inches from the seed.

APPLICATIONS FOR LEGUMES (including Soybeans, Dry Beans, Peas, Lentils): Do not apply in-furrow. Apply 1-5 gallons 2 inches below and to the side of the seed line. Avoid direct, on-seed applications.

COMPATIBILITY: The compatibility of TILL-IT PERFECTO with other products may vary. Proposed mixtures should be evaluated in a jar test before full scale use. Do not mix this product with calcium fertilizers. Consult your area Wilbur-Ellis representative for further recommendations.
