TILL-IT POP-UP is designed for in-seed row placement at planting time to provide phosphate in a readily available form to strengthen early seedling growth and enhance stand uniformity.

TILL-IT POP-UP should be used as part of a comprehensive Total Nutrition System for optimizing plant growth, development, yield and quality. TILL-IT products are water soluble and move well in the soil solution. TILL-IT products may be applied separately or in combination with fertilizers or pesticides.

DIRECTIONS FOR USE

Moisture conditions and planting strategies are important considerations when using TILL-IT POP-UP. If irrigation or adequate rainfall will germinate the crop, TILL-IT POP-UP can be applied directly on top of the seed. If planting to moisture or under marginal moisture conditions, TILL-IT POP-UP should be applied to the bottom of the seed furrow and the seed placed on top of the treated soil. For added safety, use TILL-IT POP-UP with equal parts water.

CORN, SORGHUM, AND GRAINS: Use 3-15 gallons per acre.
