#### DIRECTIONS FOR USE

**TILL-IT REKOIL** may be used on all tree, vine, field, row or vegetable crops.

##### SOIL APPLICATION DIRECTIONS:

For young trees, use up to 15 gallons per acre starting at full leaf. Apply **TILL-IT REKOIL** every 3-4 weeks as needed.

For mature trees, apply up to 30 gallons per acre, every 3-4 weeks as needed.
