TILL-IT RHIZOSTIM is a dry blend designed to prevent and correct nutrient deficiencies through banded or broadcast applications. This product is suggested as a supplement to a regular balanced fertilizer program to enhance yield and improve quality. It should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

TILL-IT RHIZOSTIM is recommended to prevent nutrient deficiencies determined by tissue or soil analysis. Mechanical or water incorporation is recommended after application.

Preferred rate is 500 lbs per acre as a band or broadcast. Rates between 100 and 2000 pounds per acre can be applied.

Consult with a Wilbur-Ellis representative for rates specific to your crop and conditions.

COMPATIBILITY: Avoid creating dust when handling and keep away from water. Always jar test new combinations prior to field mixing.
