DIRECTIONS FOR USE

Apply **TILL-IT STRIP-TILL** using recommended rates and directions with your nutrient management plans. **TILL-IT STRIP-TILL** can be applied via broadcast, banding, or through irrigation on all row crops and permament crops. Placement 2-4 inches below and to the side of seed placement is recommended, do not apply **TILL-IT STRIP-TILL** directly on seed.

ROW CROPS: Apply 5-70 gallons per acre, as a broadcast, injection, or through irrigation. Incorporation is recommended.

OTHER CROPS: Apply 5-50 gallons per acre, as a broadcast, drip-injection, or band. Incorporation is recommended.
