DIRECTIONS FOR USE

Apply **TILL-IT TOP DRESS** using recommended rates and directions with your nutrient management plans. **TILL-IT TOP DRESS** can be applied via broadcast or band on all row crops and permament crops. Broadcast and/or shallow incorporation applications are preferred. Do not apply **TILL-IT TOP DRESS** directly on-seed.

ROW CROPS: Apply 5-70 gallons per acre, as a broadcast, injection, or through irrigation.

OTHER CROPS: Apply 5-50 gallons per acre, as a broadcast, drip-injection, or band.
