Use of this product is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Soil applications of may be particularly beneficial in soils with low to medium nitrogen levels.

This product should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield, and quality.

DIRECTIONS FOR USE

TILL-IT WIRED N-SHIELD 41-0-0 is recommended to prevent nitrogen, sulfur and zinc deficiencies determined by tissue or soil analysis as an amendment.

Preplant or In-season:

Preferred application rate is 200 pounds per acre as a band or broadcast. Rates between 100-550 pounds per acre can be applied.

Consult your area Wilbur-Ellis representative for specific uses and rates.

COMPATIBILITY: Avoid creating dust when handling and keep away from water. Always jar test new combinations for compatibility prior to field mixing.
