GENERAL INFORMATION

TILL-IT WIRED PHOS is a blend of nitrogen, phosphate, sulfur, and micronutrients designed to prevent and correct nutrient deficiencies through banded and broadcast applications. The inclusion of watersoluble humic acids may aid with micronutrient uptake. Use of this product is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Soil applications may be particularly beneficial in soils with low to medium phosphate levels.

TILL-IT WIRED PHOS should be used as part of a comprehensive Total Nutrition System[®] for optimizing soil/nutrient conditions for plant growth, development, yield, and quality.

DIRECTIONS FOR USE

TILL-IT WIRED PHOS is recommended to prevent nutrient deficiencies determined by tissue or soil analysis as a fertilizer. Mechanical or water incorporation is recommended after application. Applications with seed should take total salt index, soil type, and application rate into account before application.

AT SEEDING: Preferred application rate with seed is 75 pounds per acre. Rates between 25-100 pounds per acre can be applied.

PREPLANT OR IN-SEASON: Preferred application rate is 150 pounds per acre as a band or broadcast. Rates between 50-300 pounds per acre can be applied.

COMPATIBILITY: Avoid creating dust when handling and keep away from water. Always jar test new combinations for compatibility prior to field mixing.
