GENERAL INFORMATION

TILL-IT[®] ZONED[®] is a low salt index liquid fertilizer designed for starter or pop-up applications. TILL-IT ZONED may be applied below, to the side or in the seed furrow of most crops depending on local conditions and established agricultural practices. TILL-IT ZONED contains fully chelated micronutrients. Avoid foliar nutrient applications to crops during periods of moisture, salinity or heat stress. Applications of foliar nutrients to sensitive crops such as leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury.

TILL-IT ZONED should be used as part of a comprehensive Total Nutrition System[®] for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

TILL-IT ZONED may be applied to soil or directly in seed row at time of planting (pop-up). Avoid direct application to seed on very dry soil if no rainfall or irrigation is to follow within 24 hours. For low rate pop-up applications dilution with water may aid in field calibration, depending on application equipment. Bluegrass, canola, rape, mustard, soybeans, and other small seed crops should have TILL-IT ZONED placed no closer than 2 inches from the seed.

SOIL APPLICATIONS: TILL-IT ZONED is a premium quality, low salt index fertilizer that can be applied to seeded crops at the rates suggested here. Apply to seed zone at the time of planting. Canola: 2-3 gallons per acre.

Corn: 2-4 gallons per acre.

Dry Beans: 2-3 gallons per acre

Flax: 2-3 gallons per acre.

Legumes: 2-3 gallons per acre.

Potatoes: 3-5 gallons per acre.

Small Grains: 2-3 gallons per acre.

Sunflowers: 2-3 gallons per acre.

FOLIAR APPLICATIONS: TILL-IT ZONED may be applied as a foliar spray by air or by ground. Maintain agitation to provide uniform distribution within the spray tank. Always include a high quality wetting agent, such as R-11[®] or SYL-COAT[™], at recommended rates.

Alfalfa: 1-8 quarts after re-growth between cuttings on alfalfa.

Corn: 1-8 quarts.

Field Crops: 1-8 quarts per acre prior to or during crop peak phosphate demand.

Legumes: 1-8 quarts per acre at pre-bloom to 10% bloom.

Potatoes: 1-8 guarts at 7 to 10-day intervals.

Small Grains: 1-8 quarts per acre just prior to peak demand of phosphate needs.

Do not mix **TILL-IT ZONED** with calcium fertilizers. **TILL-IT ZONED** is compatible with many coapplied nutrient sources as well as plant protection products. Always jar test new combinations for compatibility prior to field mixing.
