RECOMMENDATIONS

TRACITE® LIQUID SULFUR SIX may be used on most crops. Make applications of this product on the basis of foliar or soil nutrient availability test. In the absence of these tests, a general application rate of 1 to 8 pints of product may be used.

Cucurbit crops such as watermelons, cantaloupes, cucumbers and squash are very sensitive to sulfur. Use this product on those crops with extreme caution.

Apply **TRACITE® LIQUID SULFUR SIX** in enough water for thorough coverage of the soil.

Suggested Application Dilutions:

Dilute:

Field and Row Crops: 20 to 60 gallons of water per acre.

Orchard: 100 to 800 gallons of water per acre.

Concentrate:

Field and Row Crops: 5 to 10 gallons of water per acre.

Orchard: 20 to 100 gallons of water per acre.

Chemigation Sprinkler Irrigation Systems:

Use sufficient water to provide thorough coverage of the soil.

RECOMMENDATION FOR ADJUSTING SOIL pH

Use 1-5 gallons per acre to reduce soil pH to desired range.
