### GENERAL INFORMATION

This is a custom formulation and is intended for the exclusive use by the buyer.

**TRACITE® N ZINC** is a micronutrient designed for foliar or soil application. It is recommended for use as an additive in dry or liquid fertilizers and is compatible with most of the herbicides, insecticides and agricultural chemicals that can be utilized in combination with liquid fertilizers. **TRACITE® N ZINC** may not be compatible with some liquid fertilizer formulations. A pre-mix "jar test" is recommended prior to mixing with liquid fertilizer to check compatibility.

**NOTE:** **TRACITE® N ZINC** cannot be used in liquid fertilizers which contain orthophosphates.

When used as directed, this product does not supply all nutrients required by plants and is to supplement a soil fertility program based on soil tests.

### RECOMMENDED CROPS

**TRACITE® N ZINC** can be applied to the following crops: Vegetables, fruit, row crops, deciduous fruit and nut trees, citrus trees and commercial turf and ornamentals.

### APPLICATION AND MIXING GUIDE

Rates and timing of applications are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis and in conjunction with your local agricultural authority.

**TRACITE® N ZINC** may be applied by ground or aerial application:

**High volume sprayers:** Use 130-800 gals. water per acre.

**Conventional field crop sprayers:** Use minimum of 15-20 gals. per acre or enough water for thorough coverage.

**Air application:** Use minimum of 5 gals. of water per acre. Use enough water for thorough uniform coverage of foliage or soil.

Thorough coverage is necessary for best results and the addition of a nonionic surfactant such as **INDUCE®** is recommended.

**MIXING:** In any mixing operation, **TRACITE® N ZINC** should be introduced in the following sequence:

- Water
- TRACITE® N ZINC**
- Other Fertilizers or Pesticides.

In mixtures where a compatibility agent is suggested, a product such as **BLENDEx® VHC** is recommended.

Local climatic conditions, infestations and other factors affect the performance of any insecticide, fungicide and nutritional spray. Therefore for specific use, consult your local Helena Chemical Company representative or your local agricultural extension agent.
