## GENERAL RECOMMENDATIONS

TRACITE® PEANUT PACKER™ can be used on all crops for the prevention and correction of micronutrient deficiencies.

## FOLIAR APPLICATIONS:

Peanut and other Row Crops: Apply 1-2 qts. per acre per application every 2-3 weeks for a maximum of 4 applications. Use 10-20 gallons of water per acre for ground spray equipment and at least 5 gallons for aerial application. Agitate thoroughly.

## DIRECTIONS FOR USE

TRACITE® PEANUT PACKER™ readily mixes in water and is compatible with most pesticides.

**DO NOT USE WITH PESTICIDES THAT CONTAIN 2,4DB ACID (LIKE BUTOXONE® 175 HERBICIDE).**

**DO NOT MIX WITH HIGH PHOSPHATE FERTILIZERS SUCH AS 10-34-0.**
