#### **GENERAL INFORMATION**

TRACITE® WESTERN ZFM II is a complexed micronutrient designed for foliar or soil application. It is recommended for use as an additive in dry or liquid fertilizers and is compatible with herbicides, insecticides, and most agricultural chemicals that may be utilized in combination with liquid fertilizers. TRACITE® WESTERN ZFM II may not be compatible with some liquid fertilizer formulations. A pre-mix "jar test" is recommended prior to mixing with liquid fertilizers.

TRACITE® WESTERN ZFM II is an effective pH buffering agent. The addition of TRACITE® WESTERN ZFM II at a rate of 1 quart in 500 gallons of water will decrease alkaline hydrolysis associated with all organo-phosphate insecticides.

## RECOMMENDED CROPS

TRACITE® WESTERN ZFM II can be applied to the following crops: All vegetables, grapes, row crops, deciduous fruit and nut trees, citrus, avocados, ornamentals and truf

## GENERAL APPLICATION RATES

The following rates have proven successful in correcting deficiencies:

#### FOLIAR:

¼-1 gallon per acre depending on the crop and the severity of the deficiency. The use of a soil or plant tissue analysis is recommended for determining the proper application rate.

#### MIXING AND APPLICATION GUIDE

High Volume Sprayer: Use 350-800 gallons of water per acre.

Conventional Field Crop Sprayers: Use a minimum of 20 gallons of water per acre. Low Volume Sprayers: Use a minimum of 5 gallons of water per acre.

Aircraft Spraying: Use a maximum of 1 quart of TRACITE® WESTERN ZFM II per gallon of water.

Mixing: In any mixing operation, TRACITE® WESTERN ZFM II should be introduced in the following sequence:

- 1 Water
- 2. TRACITE® WESTERN ZFM II
- Other Fertilizers or Pesticides
