TraFix® Es CAL Eight™ may be added to irrigation water or can be applied as a side-dress application on all crops including vegetable crops, row crops, field crops, feed crops, trees and vines.

TraFix® Es CAL Eight™ is a low pH fertilizer and Calcium (Ca) source. Treating irrigation water will lower the water pH.

Mixing TraFix® Es CAL Eight™ with other fertilizers or with an amendment is not recommended unless jar tests beforehand indicate compatibility.

DIRECTIONS FOR USE

Drip Tape: 1-5 gallons per acre per application of TraFix® Es CAL Eight™.

Center Pivot Irrigation Systems: 1-5 gallons per acre per application of TraFix® Es CAL Eight™.

Water-run: Apply 1-5 gallons per acre per application of TraFix® Es CAL Eight™ as a water-run in the crop's irrigation water.

Side-dress Applications to Soil: TraFix® Es CAL Eight™ can be knifed into the soil at rates of 1-5 gallons per acre per application. Water dilution to achieve calibration accuracy is recommended.

TraFix® Es CAL Eight™ is not designed for foliar application.
