#### THIS PRODUCT IS NOT COMPATIBLE WITH ORTHO-BASED PHOSPHATE FERTILIZERS. IT IS COMPATIBLE WITH POLYPHOSPHATE FERTILIZERS.

Rate of application is 2-3 quarts per acre. FOR WISCONSIN ONLY: Rate of application is 2 quarts per acre. Do not exceed this recommended rate in Wisconsin. The timing of applications are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis. For specific use recommendations, consult your local Helena Chemical Company representative or your local agricultural extension agent.
