### DIRECTIONS FOR USE

**BANDING:** Prior to planting, apply 3 to 6 gallons per acre banded over plantline prior to transplanting.

TRANSPLANT PLUS can be combined with pesticides. However, when use of an unfamiliar mix is made, a compatibility test is always recommended.

**TRANSPLANT WATER:** Apply 3 to 6 gallons in 800-1200 gallons per acre of transplant water.

**WATER RUN:** Apply 3 to 6 gallons per acre in irrigation water after transplanting.

### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
