

PRODUCT INFORMATION

TREVO DCZ is a broad-spectrum product containing two fungicides. It has preventative, systemic and curative properties and is specified for the control of many important plant diseases. TREVO DCZ provides excellent disease control of many leaf spots and powdery mildews. TREVO DCZ is applied as a foliar spray and can be used in block, alternating spray or tank-mix programs with other crop protection products. All applications need to be made according to the use directions that follow.

USE PRECAUTIONS AND RESTRICTIONS

FAILURE TO FOLLOW DIRECTIONS AND PRECAUTIONS ON THIS LABEL MAY RESULT IN CROP INJURY. POOR DISEASE CONTROL. AND/OR ILLEGAL RESIDUES.

ATTENTION

TREVO DCZ is extremely phytotoxic to certain apple varieties.

AVOID SPRAY DRIFT. Extreme care must be used to prevent injury to apple trees (and apple fruit)

- DO NOT spray TREVO DCZ where spray drift may reach apple trees.
- DO NOT spray when conditions favor drift beyond area intended for application.

USE INFORMATION

Application: Thorough coverage is necessary to provide good disease control. Make no more spray solution than is needed for application. Avoid spray overlap, as crop injury may occur.

Adjuvants: When an adjuvant is to be used with this product, the use of an adjuvant that meets the standards of the Chemical Producers and Distributors Association (CPDA) adjuvant certification program is advised.

Use of Adjuvants: Under certain weather conditions (particularly high temperatures) TREVO DCZ in combination with high rates of silicone-based or oil containing (petroleum or crop) additives or adjuvants may cause injury. DO NOT exceed 0.125% adjuvant (v/v). Consult an INNVCTIS CROP CARE representative for more information concerning additives or adjuvants.

Precaution: A tank mixture with Dimethoate may cause crop injury.

On fresh market tomatoes, **DO NOT** use adjuvants or tank mix *TREVO DCZ* with any EC product.

Efficacy: Under certain conditions conducive to extended infection periods, use another registered fungicide for additional applications if the maximum amount of TREVD DCZ has been used. If resistant isolates to Group 3 or Group 11 fungicides are present, efficacy can be reduced for certain diseases. The higher rates in the rate range and/or shorter spray intervals may be required under conditions of heavy infection pressure, with highly susceptible varieties, or when environmental conditions are conducive to disease.

Integrated Pest Management (IPM): TREVO DCZ need to be integrated into an overall disease and pest management strategy whenever the use of a fungicide is required. Cultural practices known to reduce disease development need to be followed. Consult your local agricultural authorities for additional IPM strategies established for your area. TREVO DCZ may be used in State Agricultural Extension advisory (disease forecasting) programs which advise anolication timino based on environmental factors favorable for disease development.

Resistance Management

For resistance management, please note that TREVO DCZ contains both azoxystrobin, a stroblium fungicide in Group 11 and difencoonazole, a triazole fungicide in Group 3. Any fungal population may contain individuals naturally resistant to either or both of the active ingredients in TREVO DCZ and other Group 11 or Group 3 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

- To delay fungicide resistance, take one or more of the following steps:
- · Apply a maximum of 4 sprays during one crop cycle.
- Apply no more than 2 sequential applications unless otherwise stated in the crop section.

- Rotate the use of TREVO DCZ or other Group 11 and 3 fungicides within a growing season sequence with different groups that control the same pathogens.
- Use tank mixtures with fungicides from a different group that are equally effective on the target pest when such use is permitted. Use at least the minimum application rate as labeled by the manufacturer.
- Adopt an integrated disease management program for fungicide use that includes scotting, uses historical information related to pesticide use, and crop rotation, and which considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications. Note that using predictive models alone is not sufficient to manage resistance.

Crop Sensitivity: Plant sensitivity has been found to be acceptable for all crops on the label, however, not all possible tank-mix combinations have been tested under all conditions. When possible, it is advised to test the combinations on a small portion of the crop to ensure that a phytotoxic response will not occur as a result of application. MANDATORY SPRAY DRIFT

Aerial Applications

- DO NOT release spray at a height greater than 10 ft above the vegetative canopy, unless a greater application height is necessary for pilot safety.
- For all applications, applicators are required to use a medium or coarser spray droplet size (ASABE S572.1).
- The boom length must not exceed 65% of the wingspan for airplanes or 75% of the rotor blade diameter for helicopters.
- Applicators must use ½ swath displacement upwind at the downwind edge of the fold
- Nozzles must be oriented so the spray is directed toward the back of the aircraft.
- . DO NOT apply when wind speeds exceed 10 miles per hour at the application site.
- DO NOT apply during temperature inversions.

Ground Applications

- Apply with the nozzle height recommended by the manufacturer, but no more than 3
 feet above the ground or crop canopy.
- For all applications, applicators are required to use a medium or coarser spray droplet size (ASABE S572.1).
- DO NOT apply when wind speeds exceed 10 miles per hour at the application site.
- . DO NOT apply during temperature inversions.

Boom-less Ground Applications:

- Applicators are required to use a medium or coarser droplet size (ASABE S572.1) for all applications.
- DO NOT apply when wind speeds exceed 10 miles per hour at the application site.
- DO NOT apply during temperature inversions.

SPRAY DRIFT ADVISORIES

THE APPLICATOR IS RESPONSIBLE FOR AVOIDING OFF-SITE SPRAY DRIFT.
BE AWARE OF NEARBY NON-TARGET SITES AND ENVIRONMENTAL CONDITIONS.

IMPORTANCE OF DROPLET SIZE

An effective way to reduce spray drift is to apply large droplets. Use the largest droplets that provide target pest control. While applying larger droplets will reduce spray drift, the potential for drift will be greater if applications are made improperly or under unfavorable environmental conditions.

Controlling Droplet Size - Ground Boom

- Volume Increasing the spray volume so that larger droplets are produced will reduce spray drift. Use the highest practical spray volume for the application. If a greater spray volume is needed, consider using a nozzle with a higher flow rate.
- Pressure Use the lowest spray pressure recommended for the nozzle to produce the target spray volume and droplet size.
- Spray Nozzle Use a spray nozzle that is designed for the intended application. Consider using nozzles designed to reduce drift.

Controlling Droplet Size - Aircraft

Adjust Nozzles - Follow nozzle manufacturers recommendations for setting up nozzles.
 Generally, to reduce fine droplets, nozzles should be oriented parallel with the airflow in flight.

BOOM HEIGHT - Ground Boom

Use the lowest boom height that is compatible with the spray nozzles that will provide uniform coverage. For ground equipment, the boom should remain level with the crop and have minimal bounce.

RELEASE HEIGHT - Aircraft

Higher release heights increase the potential for spray drift. When applying aerially to crops, Do NOT release spray at a height greater than 10 ft above the crop canopy, unless a greater application height is necessary for pilot safety.

SHIELDED SPRAYERS

Shielding the boom or individual nozzles can reduce spray drift. Consider using shielded sprayers. Verify that the shields are not interfering with the uniform deposition of the spray on the target area.

TEMPERATURE AND HUMIDITY

When making applications in hot and dry conditions, use larger droplets to reduce effects of evaporation.

TEMPERATURE INVERSIONS

Drift potential is high during a temperature inversion. Temperature inversions are characterized by increasing temperature with altitude and are common on nights with limited cloud cover and light to no wind. The presence of an inversion can be indicated by ground fog or by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing. Avoid applications during temperature inversions.

WIND

Drift potential generally increases with wind speed. AVOID APPLICATIONS DURING GUSTY WIND CONDITIONS.

Applicators need to be familiar with local wind patterns and terrain that could affect spray drift

- Boom-less Ground Applications: Setting nozzles at the lowest effective height will help to reduce the potential for spray drift.
- · Handheld Technology Applications: Take precautions to minimize spray drift.

MIXING AND APPLICATION METHODS

Spray Equipment

Nozzles

- Equip sprayers with nozzles that provide accurate and uniform application.
- Use the same size nozzles uniformly spaced across the boom.
- · Calibrate sprayer before use.
- Use screens to protect the pump and to prevent nozzles from clogging.
- On suction side of pump use screens that are 16-mesh or coarser.
- DO NOT place a screen in the recirculation line.
- Use 50-mesh or coarser screens between the pump and boom, and where required, at the nozzles.
- Check nozzle manufacturer's directions

Pump

- . Use a pump with capacity to:
- Maintain 35-40 psi at nozzles.
- Provide sufficient agitation in tank to keep mixture in suspension this requires recirculation of 10% of tank volume per minute.
- . Use a jet agitator or liquid sparge tube for agitation.
- . DO NOT air sparge.

For more information on spray equipment and calibration, consult sprayer manufacturer's and state directions/specifications. For specific local directions and spray schedules, consult the current state agricultural specifications.

Mixing Instructions

- TREVO DCZ is a suspension concentrate (SC) formulation.
- Prepare no more spray mixture than is required for the immediate operation.
- Thoroughly clean spray equipment before using this product.
- Agitate the spray solution before and during application.
- Rinse spray tank thoroughly with clean water after each day's use and dispose of pesticide rinsate by application to an already treated area.

TREVO DCZ Alone (No Tank Mix)

- Add 1/2 2/3 of the required amount of water to the spray or mixing tank.
- . With the agitator running, add TREVO DCZ to the tank.

- Continue agitation while adding the remainder of the water.
- Begin application of the spray solution after TREVO DCZ has completely dispersed into the mix water.
- . Maintain agitation until all of the mixture has been sprayed.

TREVO DCZ + Tank Mixtures: TREVO DcZ is usually compatible with tank-mix partners listed on this label. To determine the physical compatibility of TREVO DcZ with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to 1 qt of water. Add wettable powders and water dispersible granular products first, then liquid flowables, and emulsfinable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

Tank Mixtures: All directions for use, crops/sites, use rates, dilution rates, precautions, and limitations which appear on the tank-mix product label must be observed. The label dosage for the tank-mix partner is not to be exceeded, and the most restrictive label precautions and limitations are to be followed.

Mixing in the Spray Tank

- Add 1/2- 2/3 of the required amount of water to the spray or mixing tank.
- With the agitator running, add the tank-mix partner(s) into the tank in the same order as described above.
- Allow the material to completely dissolve and disperse into the mix water. Continue
 agitation while adding the remainder of the water and TREVO DCZ to the spray tank.
- Allow TREVO DCZ to completely disperse.
- . Spray the mixture with the agitator running.
- Observe all directions for use, crops/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix product label.
- Label dosage rate must not be exceeded, and the most restrictive label precautions and limitations must be followed.
- This product must not be mixed with any product which prohibits such mixing.
- It is the pesticide user's responsibility to ensure that all products are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Application Instructions

TREVO DCZ may be applied with many types of spray equipment commonly used for making ground and aerial applications. Proper adjustments and calibration of spraying equipment to give good canopy penetration and coverage is essential for good disease control.

Ground Application

- Apply in a minimum of 10 gal of water per acre, unless specified otherwise.
- . DO NOT apply through any ultra-low volume (ULV) spray system.
- Thorough coverage is necessary to provide good disease control.

Aerial Application

- Use only on crops where aerial applications are indicated.
- · Thorough coverage is necessary to provide good disease control.
- Apply in a minimum of 5 gallons of water per acre unless specified otherwise.
- DO NOT apply under conditions when uniform coverage cannot be obtained or when
 excessive spray drift may occur.
- DO NOT apply directly to humans or animals.
- DO NOT apply through any ultra-low volume (ULV) spray system.

Application Through Irrigation Systems (Chemigation)

- Use only on crops for which chemigation is specified on this label.
- Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. DO NOT apply this product through any other type of irrigation system.
- Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.
- Apply in 0.1-0.25 inches/acre. Excessive water may reduce efficacy.
- If you have questions about calibration, you must contact State Extension Service specialists, equipment manufacturers, or other experts.
- D0 NOT connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system, unless the pesticide label-prescribed safety devices for public water systems are in place.
- A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments if the need arise.

Operating Instructions

- The system must contain a functional check-valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check-valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- The system must contain functional interlocking controls to automatically shut off the
 pesticide injection pump when the water pump motor stops.
- The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, including a positive displacement injection pump (e.g., diaphragm pump), effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. **DO NOT** apply when wind speed favors drift beyond the area intended for treatment.

Center Pivot Irrigation Equipment

Notes: (1) Use only with drive systems which provide uniform water distribution. (2) **D0 NOT** use end guns when chemigating *TREVO DCZ* through center pivot systems because of non-uniform application.

- Determine the size of the area to be treated.
- Determine the time required to apply 1/8-1/2 inch of water over the area to be treated when the system and injection equipment are operated at normal pressures as directed by the equipment manufacturer. When applying TREVO DCZ through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Run the system at 80-95% of the manufacturer's rated capacity.
- Using water, determine the injection pump output when operated at normal line pressure.
- Determine the amount of TREVO DCZ required to treat the area covered by the irrigation system.
- Add the required amount of TREVO DCZ and sufficient water to meet the injection time requirements to the solution tank.

- Make sure the system is fully charged with water before starting injection of the TREVO DCZ solution. Time the injection to last at least as long as it takes to bring the system to full pressure.
- Maintain constant solution tank agitation during the injection period.
- Continue to operate the system until the TREVO DCZ solution has cleared the sprinkler head

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

- Determine the acreage covered by the sprinklers.
- Fill injector solution tank with water and adjust flow rate to use the contents over a 20- to 30-minute interval. When applying TREVO DCZ through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution.
- Determine the amount of TREVO DCZ required to treat the area covered by the irrigation system.
- Add the required amount of TREVO DCZ into the same quantity of water used to calibrate the injection period.
- Operate the system at the same pressure and time interval established during the calibration.
- Stop injection equipment after treatment is completed. Continue to operate the system
 until the TREVO DCZ solution has cleared the last sprinkler head.

SPECIFIC INSTRUCTIONS FOR PUBLIC WATER SYSTEMS

- Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
- 2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, back-flow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system needs to be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.
- The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- 4. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- 5. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
- Systems must use a metering pump, including a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. **DO NOT** apply when wind speed favors drift beyond the area intended for treatment.
