Do not give anything by mouth to an unconscious person. **If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

Do not allow packets to freeze. Do not expose packets to direct sunlight or excessive heat.

- Protect the packets from moisture prior to usage.
- Minimize handling to avoid breakage, and reseal the outer bags to protect unused packets.

#### MIXING INSTRUCTIONS

1. Fill the spray tank 1/2 full of water. For paddle agitation systems, paddles should at least be partially covered with water.
2. Activate agitation system.
3. Add water soluble packets.
4. Continue filling the tank while the packets dissolve and dispense.

TARGET AREA	PACKETS PER 50 GALLONS
Greens	1
Fairways/Lawns	1 to 2
Roughs, etc.	1 to 2

#### Rates for use as an indicator for termiticide pre-treatment

Wood structures ..... 1 WSP/500 gallons  
 Pre-slab/Soil..... 1 to 2 WSP/100 gallons  
 Allow 5 minutes of mixing for packets to dissolve in the spray solution.

**Clean-Up:** TURF TRAX BLUE washes out of clothing in a normal laundry process. To wash off of skin, use hot soapy water. Color is quickly eliminated with household bleach.
