

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS**

CAUTION: Harmful if swallowed, absorbed through skin or inhaled. Avoid breathing vapor or spray mist. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

DIRECTIONS FOR USE: Shake well before using.

MIXING

1. Fill spray tank ½ full of water and begin agitation.
2. Add recommended amount of ULTRA PRO.
3. Add pesticides as directed by label or in the following sequence and continue filling tank.
 1. Dry flowables or water dispersible granules
 2. Wettable powders
 3. Flowables
 4. Solutions
 5. Emulsifiable concentrations
4. Continue agitation until spray solution is completely mixed.

RECOMMENDATIONS

Specific use rates will vary with conditions of application such as water hardness, application method, equipment, spray droplet size, condition of foliage, etc. Rates of ULTRA PRO higher than those below may be used if recommended by pesticide labeling. Follow pesticide label directions.

However, do not add this product at a rate which exceeds 5% of the finished spray volume.

Herbicides, Defoliants, Desiccants: 4-8 quarts per 100 gallons of finished spray volume.

For improved efficiency, use at least 1 pint of ULTRA PRO per acre when finished spray volume is less than 20 gallons per acre. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

STORAGE & DISPOSAL

STORAGE: Keep in original container. Do not reuse empty containers. Store in cool, dry place. Protect from excessive heat.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or at an approved waste disposal facility.
